

## National Representative Contract

This Contract is made on this day ..... between **INTERNATIONAL BODYGUARD AND SECURITY SERVICES ASSOCIATION** (Registered n°P00000019902 hereby known as **IBSSA**), represented by

### 1. PURPOSE OF THE CONTRACT

The "IBSSA" grants "the Representative" a license to promote the IBSSA brand name and system of training, techniques and syllabus to:

- Promote activities and events in the "IBSSA" name

- Take into membership such people wanting to join the "IBSSA ....." upon behalf of "IBSSA"

### 2. THE NOMINATION:

Will be IBSSA ..... and ..... will be the National Representative.

### 3. TERRITORY

The "Representative" may distribute and promote products and services within the territory of ..... and the activities in this territory are the competence of IBSSA .....

4. THE IBSSA ..... oblige itself to fulfill at least n° 50 IBSSA full members (250 USD) or 80 IBSSA Supporting Company Members for a total sum of 10.000 USD per year.

In this case the IBSSA ..... has the right for 5 more ID cards free.

Under all these membership fees the IBSSA ..... has the right of 20% (twenty percents) of the fee.

5. THE IBSSA ..... has the full right to use the International IBSSA Copyright Registration n° 20119D2000 on the whole duration of this contract and in all promotional, commercial and operative activities.

### 6. EDUCATION AND PREPARATION COURSES

The IBSSA ..... has the right to organize all types of the IBSSA Preparation Courses but with obligation that all the exams to have as supervisor one of the Education of Qualification Department members as follows: Rony Kluger - Israel, G. Spartaco Bertoletti - Italy, Silvere Salvisberg - Switzerland, Miklos Varga - Hungary, Peter Richter - Slovakia or if they are busy, one of the supplementary members as follows: Giuseppe Morabito - Italy, Iulian Moisescu - Romania, Oliver Rozsa - USA.

Every time they organize the IBSSA course, the following sums should be transferred at the IBSSA HQ:

25 USD for every Participation Certificate and Passport

50 USD for every Qualification Certificate.

### 7. PAYMENT:

The payment of the Contract should be made in *4(four) rates of 2500 USD each (two thousand five hundred US dollars) beginning with February 2001*. The renewal of the contract can be made every year until March.

8. THE IBSSA ..... have to announce one of the generals HQ about all promotional preparation or any other kind of activities in the name of IBSSA.

9. DURATION OF THE CONTRACT

This contract will run for a period of one year from January 2001 till December 31<sup>st</sup> 2001 with the possibility to renew it.

10. THE REPRESENTATIVE'S COVENANTS

Under this Contract "the Representative" will:

- undertake to pay the sum of 10.000 USD to IBSSA bank account No.265210 (USD) at General Banking and Trust CO. Ltd – Budapest, 1051 Arany Janos u 25., Hungary on an annual basis the first amount being due the day of signing of this contract, being renewed on the same date thereon after:
- supply written articles and photographs on a regular basis for inclusion into "Sportivo IBSSA Official Magazine".
- maintain the highest standard of good behavior and integrity at all times whenever is representing the "IBSSA" anytime, anywhere in the world.
- not pass on to any third party and company any rights or privileges set out in this Contract.
- not purchase or sell similar products or services offered by another manufacture, organization or distributor
- uphold and have all people, acting under the control and direction of "the Representative" in ..... – the rules, regulations to comply with procedures of "IBSSA"

11. THE "IBSSA" COVENANTS

The "IBSSA" covenants to:

- supply certificates and materials upon receipt of the relevant application forms endorsed by "the Representative"
- promote "the Representative" through a series of articles in "Sportivo Magazine" and on the IBSSA web sites his organization.
- directly encourage and promote "the Representative" as the only representative of the IBSSA in .....
- on receipt of the annual fee, the " IBSSA" shall send to "the Representative" an official representative certificate.
- make available merchandise and equipment at agreed prices

12. TERMINATION

Notice of Termination

This contract may be terminated without penalty to either party that 6 months notice in writing is given to the other party. Such notice is to be sent by registered mail.  
If both parties agree a shorter period of notice can be negotiated.

13. BREACH OF THE CONTRACT

A breach of this Contract will arise due to:

- failure to make the payment by due date under the terms and conditions for sale
- use of the "IBSSA" brand outside the limitations placed by this Contract
- failure to honor the terms and conditions set out the contract, failure to uphold the rules, regulations and procedures of the "IBSSA"

14. PENALTIES FOR BREACH OF THE CONTRACT

Should either party breach this Contract the contract will be terminated automatically.

15. LAW AND JURISDICTION

- This Contract is governed by International Copyrights Laws in every particular formation and interpretation.
