Minutes of the 5th IBSSA Congress 27-29 November 1998 Hungary

Roll call

95 delegates representing 135 votes were present!

Opening

Dr. Ferenc Tóth, acting President of the Hungarian IBSSA Section welcomed all delegates and Honorary Guests of the 5th IBSSA Congress.

Chairman of the congress:

Upon proposal of the Executive President the Congress unanimously approved the General Director, Mr. Fritz Wendland, as Chairman of the Congress.

General director's report:

The General Director Fritz Wendland gave a report on the past activities of IBSSA.

4th Congress of IBSSA 1997 in Miami, Florida, USA. The minutes of the Congress were adopted unanimously.

The minutes of the Board Meeting on 3rd October 1998 in Geneva, Switzerland, were also adopted unanimously.

The General Director then proposed to the Congress the future structure of IBSSA after its formation period of the past five years, as IBSSA has now mainly companies and individuals working in the field of security. The Association should change its methods of operation. From now on the Association should follow a professional way of work as well as it should elect persons in the board who are professionals in the field of security and bodyguarding. In order to achieve this goal the statutes of IBSSA have to be updated and amended.

From now on the national IBSSA members will elect their National Coordinating President or presidium themselves. Inside the country there can be regional offices and representatives. The future leadership of IBSSA shall be composed of:

The Board of Directors, the Executive President and 4 Directors, The Executive Committee including the Board of Directors and other persons who are appointed by the Board of Directors,

The report of the General Director was adopted unanimously.

Executive President's report:

The Executive President George Popper reported that IBSSA has now more than 1.200 individual members in more than 80 countries. He told the delegates that IBSSA will distribute after two weeks an information bulletin containing all decisions and activities of the 5th IBSSA Congress.

The Executive President, also being the Treasurer in the past five years, gave the finance report of the year 1997 and the auditor's report. Both reports were adopted unanimously.

There were two questions concerning the Congresses:

Simultaneous translation: this is preferable, but is a question of money.

Cost of the Congress: the congress is the most important meeting of all the members and that is why it has to be prepared very well with a minimum of standard.

After the discussion of the budget for 1999 it was adopted unanimously.

Report of the departments:

There was the report of the Education and Qualification department and the Internet Department See annex 2, 7

Proposal for amendments of the statutes:

The General Director explained why the amendments are necessary for the future development of IBSSA. The proposed amendments were unanimously adopted.
